



Illinois Driver's License Teenager Information

1. THE DRIVER EDUCATION PROCESS

Students may enroll in a driver education course whose classroom end date is on or after their 15th birthday.

The Illinois Secretary of State states:

- A complete driver education course includes:
 - 30 hours of classroom instruction.
 - 6 hours of behind-the-wheel instruction and 6 hours of in-vehicle observation
 - or
 - 8 hours of private in-vehicle training where the observation requirement is waived.
- A student may miss a maximum of 4 classes, but each class must be made up; if the student misses more than 4 classes, he or she must re-enroll and the entire classroom training must be started over. ***Any deviation from the original class dates or times is considered a missed class stated by the administration code put forth by the Secretary of State**.*
- Driving Lessons are scheduled our online booking system.
- Cooperative Driving Test Program can only be scheduled once the student has finished their 30 Hours of Classroom, finished their Mandatory Driving Hours, and earned an A or B in the class.

2. LEARNER'S PERMIT

To receive a Learner's Permit, a student must:

- Be at least 15 years of age.
- Be enrolled in an approved driver education program and obtain a permit application from a certified driver education school.
- Bring the following to the Illinois Secretary of State:
 - Original or certified birth certificate, Illinois State ID, or Passport
 - Social Security Card if applicable.
 - The Permit application signed by a parent or guardian and a driver education instructor.
 - Proof of residency such as: a piece of mail with the parent/legal guardian name, or a school transcript or report card with the student's name and address.
 - Glasses or contacts, if they wear them.
 - \$20 cash or credit card.
- Pass a vision and a written knowledge test at a Secretary of State branch office.

■ The Permit:

- Allows the student to drive while supervised by a parent or adult and subject to restrictions (see below).
- Is valid for two years.
- Must be held for a minimum of nine months.
- Students must be in possession of the permit during all practice driving or behind-the-wheel driving lessons.

■ Permit restrictions:

- The student may not drive between the hours of 10 pm – 6 am Sunday thru Thursday or 11 pm – 6 am Friday thru Saturday.
- The number of immediate family passengers is limited to one in the front seat and to the number of seat belts in the back seat.
- During the permit phase and first year of initial licensing the student's passengers are limited to one non-immediate family member under the age of 20.
- Student must not acquire any driving convictions during the nine-month permit phase.
- Cell phone use while driving is prohibited except in the case of an emergency to contact a law enforcement agency, health care provider, or emergency services agency.

3. PRACTICE DRIVING

- To obtain a License, a student must log at least 50 hours of driving with a parent or adult, including 10 hours of night driving.
- This is a *minimum* requirement; We encourage parents to continually assess their teen to determine how many *more* hours of practice driving *their teen* would require.
- The parent/adult must be at least 21 years of age and must have held a License for at least one year.

4. CERTIFICATE OF COMPLETION

A Certificate of Completion issued by the Secretary of State is required for the student to test for his or her driver's license when they are 16 years of age and have met all permit requirements.

- Entourage Driving School applies for the Certificate of Completion with the Secretary of State upon:
 - Student's completion of all classroom and in-vehicle training (including required observations)
- The Grade Verification Form should be submitted to when enrolled to avoid delays in processing of the Certificate of Completion /License.
- Once all classroom and in-vehicle training has been completed/verified and the Grade Verification Form has been received, the Certificate of Completion normally will take 10 – 15 business days to be processed by the Secretary of State.
 - Students can then check the Secretary of State's website to determine when their Certificate of Completion has been processed: <https://www.ilsos.gov/deccheck/>. Please note that the Secretary of State does not automatically mail the Certificate of Completion however once the information has been processed in their database the student is eligible to apply for their driver's license.

5. DRIVER'S LICENSE

To test for and receive his or her Driver's License, a student must:

- Be at least 16 years of age.
- Have held his or her Learner's Permit for at least 9 months.
- Have completed a driver education program at an approved school.
- Have completed and logged at least 50 hours of practice driving with a parent or adult, including 10 hours of night driving.
- Confirm eligibility for licensure via the Secretary of State's website: <https://www.ilsos.gov/deccheck/>.
- Bring the following to the Secretary of State branch office on the testing day:
 - Learner's Permit
 - Affidavit from the student's parent or guardian attesting to the completion of at least 50 hours of practice driving, including 10 hours of night driving.
 - Illinois State ID, Original or certified birth certificate, or Passport.
 - Social Security Card
 - Proof of address if no State ID (e.g. a bill with the student's name, school transcripts with the student's address).
 - A Certificate of Residency must be completed by a parent/guardian at the Secretary of State's branch office in front of their personnel. Parents/guardians need proper personal identification (e.g. a driver's license). The certificate is provided by the Secretary of State.
 - Insurance card for the student's test vehicle.
- Pass a driving test in a vehicle provided by the student that is legally equipped, in safe/clean condition and properly registered and insured.

NOTE: DO NOT GO TO THE DMV UNLESS THEY HAVE THEIR CERTIFICATE OF COMPLETION. YOU CAN VERIFY AT ILSOS.GOV/DECHECK.

OTHER FACTS

- An appointment is necessary for a permit/road exam. They must be scheduled at [ilsos.gov](https://www.ilsos.gov). All appointments go live at 6:30 AM each day.
- If the parent accompanies the student on the testing day, they can provide their own proof of address.
- For the first 12 months of licensing or until the student turns 18, whichever comes first, the number of passengers is limited to one person under age 20, unless the additional passenger is a sibling of the driver. After this period, the number of passengers is limited to one in the front seat and to the number of seat belts in the back seat.
- All passengers aged 15-20 can be ticketed for being an extra passenger in a vehicle.
