- b) *Six Clock Hours of Behind-the-Wheel Instruction + Observation\**
- c) *Pick Up and Drop Off from a Reasonable Distance for Behind-the-Wheel Lessons*
- d) *Certificate of Completion (Formally known as the Blue Slip)*
- e) *Teen Road Test Waiver (A or B in Driver's Education Classroom)-One Attempt.*

*Note: If the student does not get an A or B, fails the CDTP test, permit gets suspended, revoked, student reaches 18 years old, goes over 9 months from the first date of classroom, or the CDTP ends abruptly, there will be no compensation\**

The cost of this course is **\$525 dollars**. Payment is due on the first day of class. **You have 9 months to complete this whole course!** Please try to finish these classes in a timely manner or you will have to pay a penalty of \$420 to re-enroll in the course. It is you and your child's responsibility to make sure they fulfill their hours in a timely manner. *Your child will have observers and/or observing other teens drive. There is a \$75 penalty if you cancel with less than 72-hour notice (3 Days) or excessive rescheduling!!!*

- c) *Pick Up and Drop Off from a Reasonable Distance for Behind-the-Wheel Lessons*
- d) *Certificate of Completion (Formally known as the Blue Slip)*
- e) *Teen Road Test Waiver (A or B in Driver's Education Classroom)-One Attempt.*
